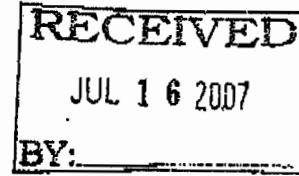

Dear Senator Cantwell:

This letter is in response to a referral dated June 13, 2007 from the U.S. Department of Justice on behalf of your constituent. In a letter dated April 9, 2007, Ms. McKinney alleges that Court Reporting Institute (CRI) fraudulently obtained federal student aid funding by compelling students to remain in its Court Reporting program with the knowledge that the students had little or no chance of successfully completing the program.

On September 30, 2003, the Department of Education (Department) began a program review of CRI located in Seattle, Washington. The purpose of the review was to determine CRI's compliance with the statutes and federal regulations as they pertain to the institution's administration of the federal student aid programs. The review consisted of, but was not limited to an examination of the school's policies and procedures regarding institutional and student eligibility, individual financial aid and academic files, attendance records, student account ledgers and fiscal records.

During this review, the Department found that CRI was improperly administering the Satisfactory Academic Progress (SAP) Policy and as a result, students were enrolled and receiving federal student aid beyond their eligibility.

In a Program Review Report dated June 1, 2005, CRI was advised of their improper application of the SAP policy and was directed to revise its policy to comply with the regulatory requirements governing federal student aid. Additionally, CRI was instructed to review all of the files of those students enrolled in the Court Reporting program identifying those that had received federal student assistance in excess of 3000-clock hours of enrollment. The institution was required to submit the results of that file review to the Department. CRI subsequently

closed. The program review has not yet been resolved, and the information provided by your constituent will be considered and retained in Department files.

Your constituent states that she and others have evidence to support allegations of fraud related to the closing of CRI on August 31, 2006. Your constituent alleges that when CRI closed, student financial assistance funds were fraudulently kept by the CRI and not paid to students or returned to the Department. We strongly recommend that she contact the Office of Inspector General with information and/or documentation related to fraud.
